The monthly administration fee for Prem1er lei package is 0 lei, provided that the client receives recurring income of at least EUR 150,000 in the last 12 months or holds resources in the BRD group of at least EUR 200,000/month.

The monthly administration fee for Prem1er Plus lei package is 0 lei, provided that the client receives recurring income of at least EUR 700,000 in the last 12 months or holds resources in the BRD group of at least EUR 500,000/month.

The monthly administration fee for Prem1er Plus EUR package is 0 EUR, provided that the client receives recurring income of at least EUR 700,000 in the last 12 months or holds resources in the BRD group of at least EUR 500,000/month.

Recurring income means income that fulfills the following cumulative conditions: (1) it comes from regular receipts: salaries, rents, pensions, allowances, scholarships or other types of regular income; (2) it is received in the current accounts held by the customer with BRD;

The amounts deriving from loans granted by the Bank, amounts deriving from matured deposits, credit transfer operations carried out from own accounts do not represent recurring income.

The BRD group (BRD - Groupe Société Générale SA, BRD Asigurari de Viata SA, BRD Asset Management SAI SA) holds resources within the BRD group (BRD - Groupe Société Générale SA, BRD Asigurari de Viata SA, BRD Asset Management SAI SA) means the end-of-month balance on current account, savings account, term deposit and investment products (government and corporate securities, shares and other financial instruments listed on the capital markets, structured placements, investment funds and insurance with an investment component).

The payment transactions that are taken into account when verifying the package condition are the following: (a) payments through the YOU BRD internet & mobile banking service, from any current account held by the Customer, representing intra-bank payments (except payments between accounts of the same customer), intra-bank payments with financial instruments, instant/standard interbank payments (including payments to the treasury), bill payments, and (b) payments made with the debit card included in the package, at the Acceptors' POS, including online payments (except for quasi-cash transactions), and bill payments made with the card at ATM/MBA/ROBO.
